95.5 NASH ICON'S "JAKE OWEN AUTOGRAPHED GUITAR" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WSM-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Eligibility. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Entries must be received by 11:59pm CT on March 21, 2021 to be eligible to win. Limit one (1) entry **per person per hour/Keyword, regardless of how many email addresses a person may possess and use.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per hour/Keyword by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number

by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

Texting in will not increase your chances of winning.

Listeners may either (i) text in an entry into a particular Contest Round using a mobile device or (ii) enter online, but not both methods. Limit one (1) entry per person/telephone number/email address per Contest Round, regardless of the method of entry chosen by a listener.

- 4. **Winner Selection.** On or about 10:00am CT on March 22, 2021, Station will select one (1) entry for a Prize in a random drawing from among all valid entries received by Station from both entry methods during the Contest Period. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within thirty (30) days of winning will result in disqualification and forfeiture of the prize.

7. Entry Conditions and Release.
