WSM/95.5 NASH ICON "SUPERSTAR SPRING TICKET GIVE-A-WAY - WEEK OF 5/15/2023" CONTEST OFFICIAL RULES

The Station will conduct the WSM/95.5 NASH ICON "SUPERSTAR SPRING TICKET GIVE-A-WAY - WEEK OF 5/15/2023" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. Caller number seven (7) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
